

CSISD Student Travel Guidelines

To be distributed to students with CSISD Student Travel Discipline Contract

Purpose Statement

The following policy has been developed and approved so that any student traveling with a CSISD student organization has the proper medical release forms, consent from the student's parent(s) or guardian(s) and has signed the discipline contract. This policy upholds the standards set by CSISD as well as the CSISD student organization.

Supervision

A CSISD employee or chaperone will supervise and accompany the participants during all activities on the trip. Students will be required to check-in with their assigned staff/chaperone periodically, as established by the sponsor. In the event that male and female participants attend an overnight trip, and if it is possible, arrangements will be made for a male and female chaperone to attend as well.

Medical Emergencies

In the event of an emergency medical situation the parent will be contacted as soon as possible. If the parent cannot be contacted the alternative emergency person will be contacted. The attached medical release form will be taken on the trip, so that in an emergency situation appropriate medical attention can be sought immediately.

Discipline Policy

The CSISD Student Code of Conduct will be in effect for the duration of all student travel.

Curfew

- A curfew of 10:00 PM is standard for all overnight trips.
- Exceptions may be made by the sponsor in the event that the sponsor establishes an earlier time or the contest, show, or convention goes past 10:00 PM.
- Chaperones will enforce the curfew with room checks at 10:00 PM.

Room Checks

- Room checks will be conducted at curfew and as needed between the hours of 10:00 PM and 6:00 AM.
- Room checks should consist of listening for noise coming from within the room and checking the halls within the
 vicinity for noise or attendees of the activity. In the event that noise is heard inside the room, the assigned
 chaperone will knock on the door and inquire.

Damages/Incurred Expenses

- The student and his/her parents will be expected to pay for any and all damage related to student behaviors that result in loss or damage to property.
- Students and his/her parents will be responsible for any long-distance calls, charges to the room, etc. although every effort will be made by the sponsor to decline these services at check-in.
- If the student is unable to attend due to academic ineligibility or cancellation at the last minute, they will not receive a refund for any costs previously incurred.

Major Infractions

The students will conduct themselves in a manner that reflects and follows the CSISD <u>Student Handbook</u> and <u>Code of Conduct.</u>

In the event that any student breaks CSISD policy or the policy set forth by the CSISD student organization, that student will be dealt with immediately and the appropriate discipline will be initiated and documented. The High School Principal will be notified immediately.

If a student violates the following stated sections of the policy, his or her parents will be contacted. In the event that a parent or guardian cannot be contacted the alternative emergency contact person, given by the parent, will be contacted. A CSISD administrator will be contacted and the student may be sent home at the expense of the parents or guardian. If it is a day trip, the parents/guardians will be required to come pick up the student. CSISD administration will conduct an investigation and follow discipline procedures in accordance with the CSISD <u>Code of Conduct</u> as appropriate. Any misbehavior may affect the student's future participation in CSISD student organization travel.

The items below are considered major infractions.

- The student is found outside of his/her room after curfew (without notifying the chaperone)
- The student has left the designated area without permission
- The student is found with any amount of drug, alcohol, vape or tobacco products
- The student is found to have partaken of any drug, alcohol, vape or tobacco product
- A male is found in a female's room or a female is found in a male's room without permission from the chaperone and a chaperone is not present
- Any student is physically fighting with another person
- Any other violation deemed as a major infraction by the advisor

In the event that you as a student find yourself around somebody violating any of the previous policies, if at all possible you are to separate yourself from that scene. The student must contact a chaperone and inform them of the situation once they have separated from it. In the event that the student is able to separate from that situation but does not, then the previously stated policy will be initiated and the student could be sent home as well.

Any illegal behavior outside the jurisdiction of the CSISD student handbook and code of conduct will be subject to legal action.

Minor Infractions

In the event that a student violates any other CSISD or CSISD student organization policy that is not deemed a major infraction, the infraction will be documented and that student's discipline will be carried forth once the group returns to College Station. The student's actions and discipline will then be turned over to the appropriate CSISD administrator.
